About this job:

The Senior Information Security Analyst: Configuration Management (SISA:CM) is responsible for aiding and helping the Information Security department with day-to-day functions of the security organization — especially as it relates to configuration Management, File Integrity, and Change Management. There will be requirements for the written side of security including writing policies and procedures, authorizing server configurations, creating baselines, identifying and creating metrics, reporting and so on.

- Center For Internet Security (CIS) Standards
- Configuration Management
- Change Management
- Tripwire (File Integrity Monitoring)

- Hardening Practices
- Risk Management

The position will report up to the Director of Information Security, but will work closely with the Chief Information Security Officer, the Information Technology department and sometimes with the compliance department as part of his or her day-to-day duties.

The ideal candidate will possess the following traits;

- A strong understanding of the basic Information Security principles
- A desire to help create a strong configuration security posture
- A desire to learn and adapt to a quickly growing Information Security program.
- A desire to pay keen attention to detail
- A willingness to adapt, grow, and change with the role.

- Validating the builds against the CIS and HIPAA standards across a range of technology
- Validating the builds of applications for CIS-like standards where CIS standards do not exist
- Running configuration management reports across systems
- File Integrity monitoring
- Creating quarterly reports related to configuration management
- Creating remediation plans related to information security
- Working with both IT and Security related to both IT and Security incidents
